REPORTS

Director's Report

SCA: Case Management/Treatment/Prevention Updates:

- SRU Institute for Nonprofit Leadership: Recovering Life Initiatives update-
The heART for Sobriety art/craft activities continue to be offered at SUCCEED each Friday from 3:00pm to 4:30pm.

The Impacting Together recovery advocacy group continues to meet on the 1st and 3rd Tuesday of each month. The meetings continue to be well attended by a core group of individuals in recovery. The group continues its focus on the development of a recovery community organization (RCO). We continue to explore potential locations for the recovery center and hope to locate/secure a site by the end of October.

- Drug Free Communities (DFC) update-
As discussed last month, our office had submitted an application for the Drug Free Communities Program through the Centers for Disease Control and Prevention (CDC). Our office participated in a group call for all applicants that were being considered for funding. The purpose of the call was to provide general award information, review critical terms and conditions of an award, address roles and responsibilities, provide information on reporting requirements, and discuss other award requirements as appropriate.

We received our official award notice last week!

- County Overdose update-
As of last week, there have been 29 confirmed overdose deaths thus far for 2023 with 7 cases still pending.

For comparison purposes: at this time last year, there had been 35 confirmed overdose deaths and 7 cases were still pending.

Department of Drug and Alcohol Programs (DDAP) Updates:

- Recovery House Licensure update-
As of last week, there are now 4 licensed recovery houses within Butler County. Three houses are licensed for adult males and one house is licensed for adult males and females.
- Regional Recovery Hub update-
Armstrong/Indiana/Clarion D&A Commission facilitated a focus group in Butler last week. The focus group primarily consisted of individuals in recovery aside from myself and Tracey Hendrix. The group reviewed the information presented during the community listening session, identified and/or expanded upon current gaps, and identified top priorities that they would like the recovery hub to assist with moving forward.

Once the recovery hub compiles all of the information collected at the focus group, a follow-up meeting via zoom will be scheduled.

- Pennsylvania Overdose Prevention Program-
On August 30th, DDAP along with Pennsylvania Commission on Crime and Delinquency (PCCD) announced the launch of the PA Overdose Prevention Program (POPP). This program

aims to build upon the progress and impacts made by the Naloxone for First Responders Program (NFRP) which was launched in 2017.

The POPP will:

- Serve as a one-stop shop for individuals and organizations seeking naloxone and related harm reduction supplies such as fentanyl and xylazine test strips;
- Serve as a clearinghouse for information, training, and technical assistance to help groups involved in harm reduction work;
- Continue emphasis on statewide and regional saturation and accessibility, with a focus on getting naloxone and harm reduction supplies into the hands of people who use drugs as well as those who provide services to them.

The benefits of transitioning from the NFRP to the POPP include:

- Accessibility of naloxone as well as fentanyl and Xylazine test strips
- Accessibility of multiple naloxone formulations (intranasal & intramuscular)
- Allocations will now be demand-based rather than formula-based
- There can potentially be multiple recognized entities within a county that will be able to receive and distribute naloxone and/or test strips within their communities rather than only having one identified centralized coordinating entity (CCE) within the county.

She reviewed the Prevention Service Data: including the Prevention/Intervention: Number of Services, Number of Individuals Served, and the Prevention Demographic Data for the month of August 2023. Three individuals are currently incarcerated, one is pending admission into treatment, and two are pending further order of the court. Four individuals will be graduating on September 21.
